The garments are comprised of a single layer PVC coated Pe-Co 390 g/m2 fabric in Orange or Yellow in six nominal sizes, the smallest being size small. The jacket has two bands of 50 mm 3M retroreflective transfer tape about the torso, sleeves and bands over each shoulder. The trousers have two bands of 60 mm retroreflective transfer tape about each leg.

The garments are also available in a two colour combination with the jacket incorporating navy blue PVC coated Pe-Co 390 g/m2 contrast fabric on the lower torso and end of sleeves, and the trousers incorporating navy blue PVC coated Pe-Co 390 g/m2 contrast fabric on the lower leg. The garments are available in five nominal sizes, the smallest being size medium.
